- Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai from the Supplier.
- Payment Terms :** 100 % Payment shall be paid on receipt, Complete Installation (acceptance) of Machine in good conditions by the consignee.
- Labelling:** The word "For use of GOVERNMENT OF MAHARASHTRA NOT FOR SALE" should be printed on each unit pack in readable Purple or Green Colours.
- Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- Delivery Challan -** Should be sent in the name of consignee in duplicate. It should specify Name of

- Equipment / Mfg. by / packing & quantity.
9. **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai, along with Bill of Entry and Country of Origin Certificate of the consignment.(For Imported Item Only)

10. **Other Terms :**

1) **Warranty:** The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare parts for further 8 years.

The Successful tenderer must ensure 100% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended with him 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered form the amount of security deposit. Certificate of such uptime/downtime issued by the end user will binding for the supplier.

Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.

2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the written down value of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.

11. **Contract Agreement:** Bidder should submit tripartite (Manufacture, Importer , HBPCL) Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause


It is a condition of the contract that all through the currency thereof, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.

12. The Bidder should submit (within 7 days) amount of 1.5% i.e. **Rs. 9,000/-** of order value to meet incidental expenditure and 3% i.e **Rs 18,000 /-**as Security Deposit in form of Bank Guarantee. This Bank Guarantee should be valid for 8 years after the expiry date of warranty issued by any Nationalized / Scheduled Bank.

1.	Noiseless aspiration unit with rapid vacuum build up mounted on a well-balanced trolley with at least four good quality antistatic castors with brakes.
2.	The machine should be based on aluminium free heat resistant piston cylinder technology with long lasting high-tech material.
3.	System should have membrane vacuum regulator & easily readable vacuum gauge in mmHg and kPa
4.	System should have maximum vacuum build up capacity of – 675 mmHg/-90kPa with a provision of setting vacuum build up levels between 0 and 675 mm Hg.
5.	System should have Clean Touch buttons providing One-touch flow.
6.	System should provide preset air flow rate of 30 L/Min
7.	The noise level should be below 37 dB
8.	System should be with a trolley having equipotential conductor for user and patient safety
9.	Should have two levels of mechanical overflow protection along with an autoclavable safety jar with auto shut off feature to prevent entry of any type of fluid into the machine
10.	System should be class I or latest guidelines Type CF compliant for providing protection against electric shock
11.	System should be compliant with IP XI - Ingress Protection to prevent ingress of foreign bodies and any type of fluid
12.	System should be two autoclavable PSU (Polysulfone) jars of 2 to 5 ltrs capacity with changeover valve for easier switching from one jar to another jar.
13.	Detachable twin jars made up of transparent material with suitable level/capacity markings/graduations and capable of withstanding 134 degree Celsius temperature while autoclaving and without getting deformed or losing clarity.

14.	System should have integrated Foot on/off switch with Regulator in the trolley.
15.	System should have high quality housings materials to withstand potent disinfectants and a smooth and a single piece hood without gaps and grooves for maintaining hygiene, easier cleaning and preventing growth of pathogens.
16.	The machine should have continuous duty cycle.
17.	System should be oil-free and should not contain any glass or stainless steel components.
18.	All components should be from a single manufacturer unless stated
19.	System should be provided with 5 sealed 2/3/5 L disposable liners made up of polyamide and polyethylene along with solidifier and bacterial filter with splash guard for closed containment of infected fluids of the same make.
20.	System should be compatible with specimen collection cup for tissue collection for biopsies
21.	Five years Comprehensive Warranty should be provided along with Technical support, required spares and consumables to be assured for five years after contract period is over.
22.	The Equipment should have European CE and USFDA. The Equipment shall have valid ISO 13485 and valid ISO-9001 Certificate.
