- Delivery Period:** 06 weeks from the date of receipt of order by the supplier to the consignee attached.
- Pre-Dispatch Inspection:** Supplier shall make necessary arrangement / facilitate to carry out Pre-Dispatch inspection as per Tender Terms & condition and submit the Inspection report to this office. The Pre-Dispatch inspection cost will be borne by supplier. Machine should be dispatched only after satisfactory Pre-Dispatch Inspection.

- 4 **Risk purchase clause:** If the bidder fails to supply the stores within the stipulated delivery period, the order will stand cancelled. Undersigned shall be entitled to purchase such stores from any other source at such price which ordinarily should not be more than 10% of the tender price. The extra expenditure in such cases shall be recovered by Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd. (Procurement Cell), Mumbai from the Supplier.
- 5 **Payment Terms:** Initial Payment of 90% of the contract value will be made within 8 weeks on delivery and successful installation. Remaining 10% of the contract value will be paid only on satisfactory commissioning and operating of the machinery.
- 6 **Labelling:** The word "**For use of GOVERNMENT OF MAHARASHTRA NOT FOR SALE**" should be printed on each unit pack in readable Purple or Green Colours.
- 7 **Acceptance & Receipt:** It should be submitted in Appropriate Format to the purchasing authority.
- 8 **Delivery Challan** - Should be sent in the name of consignee in duplicate. It should specify Name of Equipment / Mfg. by / packing & quantity.
- 9 **Invoice Copy** - Should be sent in triplicate on the Name of Managing Director, Haffkine Bio Pharmaceutical Corporation Ltd.(Procurement Cell), Mumbai. Along with Bill of Entry and Country of Origin Certificate of the consignment.
- 10 **Other Terms :**
- 1) Warranty: The warranty period shall be for 2 years from the date of commissioning of all equipment supplied as certified by the consignee. After completion of 2 years warranty period Manufacturer/Supplier should give commitment to ensure services and supply of spare part for further 8 years. The successful tenderer must ensure 100% uptime during warranty period. In case of downtime, warranty period will be extended for period of downtime. If the equipment is not attended within 24 hours for Mumbai and 48 hours for other places the supplier will be liable to pay a penalty of 0.07% of purchase cost for every day of delay. Such penalty will be recovered from the amount of security deposit. Certificate of such uptime / downtime issued by the end user will be binding for the supplier Replacement of spares parts thereof due to manufacturing defects during warranty period will be entirely at the supplier's cost.
- 2) The user institution will enter to the Comprehensive Maintenance Contract with supplier agency @ 5% of the Written down value of the equipment per year for 8 years after completion of warranty period. In case of non-compliance of CMC the supplier will be liable to pay penalty or for appropriate action. Payment of CMC on yearly basis will be made by the user's institution, at the end of the year after satisfactory performance report from the end user.
- 11 **Contract Agreement:** Bidder should submit Contract Agreement on non-judicial stamp paper of requisite value.

Fall Clause

It is a condition of the contract that all through the currency thereof, the price at which you will the supply stores should not exceed the lowest price charged by you to any customer during the currency of the contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.

➤	OT Table should be a C-Arm Compatible Table, non hydraulic leak proof design, Fully Automatic Remote Controlled with International Quality Certifications – US FDA/ European Directive CE Certificate from European Notified Body (Certificate to be submitted)
➤	It should be manufactured in ISO 9001 and ISO 13485 Certificate Facility
➤	Table should be very sturdy with Load capacity – 150 kg
➤	Design: Table should be made of SS 304 Construction and imported integrated hard plastics – Water % Spill Proof for long life and rust – free
➤	The table should be single pillar eccentric design where the weight should come at the middle section to avoid cantilever issues.
➤	The table base must have a non-metallic mounded plastic exterior for easy maintenance & for dent free long life.
➤	All lower limb and upper body crisp images should be easily obtained with C-Arm with good stability.
➤	Table top should have 4 section radiolucent table top with very low density for crisp C-Am images.
➤	This should be made of a composite material, crevices free, with no Screws/ holes on the table top surface, to prevent infection due to blood getting accumulated in the crevices, which is difficult to clean.
➤	Side Rails: sturdy Side Rails fitted on both sides for attachments
➤	Dimensions: Width: Table top should have a normal width of 480mm. For Future upgradeability, The table top should have provision for detachable width extenders on both sides, complete with padding and side rails, to achieve extra width of minimum 100 mm
➤	Controls: It should have dual control console – One on the table and the other via corded remote control. Remote control to have clear indications for all different positions
➤	Cordless Remote control: The table must also have an independent cordless remote control handset operating on Bluetooth technology, so that there is no interference to other equipment inside the operation theater. This should facilitate the anesthetist to operate the table from a distance without causing interference to the surgeon and his team.
➤	Emergency override control: the table must have an independent control system apart from control handsets so that it should be possible to operate the table even without the remote handset unit.
