

### Specification of Fully Automated Rapid Bacterial Identification & Drug Susceptibility System

1. The system should be based on reliable & proven technology for microbial identification and AST.
2. System should be capable of identifying majority of clinically relevant organism such as Gram Negative Bacteria, Gram Positive organisms, Yeasts, Anaerobes, Bacillus Spp. And fastidious bacteria such as NEISSERIA, HAEMOPHILUS.
3. AST reports to be available for all GP and GN organisms.
4. The System Should have separate AST cards for Fungal Susceptibility and should contain antifungal-Caspofungin in the Fungal AST Menu.
5. System should be fully automated right from inoculation of standardized suspension to interpretation of final AST results with traceability of all the steps involved.
